I. Call to Order

II: Introduction

President Campbell discussed the December meeting, which will also be our annual holiday potluck. She announced that the proposed Bylaws will be sent via email to every member and we will be voting to adopt them at the December meeting. She also announced that we will also be voting to approve the new Officers.

- Prop 50

President Campbell announced AADC knocked on 2300 doors in the effort to pass Prop 50.

David Hildebrand, candidate for Senate District 6, and Chris Bennet, candidate for Congressional District 3 both introduced themselves to the club and spoke briefly about their campaigns.

Andy Hayes, President of the Auburn Interfaith Food Closet informed the club about the SNAP or CalFresh program and discussed the impacts of the Government Shutdown on the program and community.

III: Approval of Minutes

- October 2025 Minutes

Motion: David Hildebrand moved to approve the minutes of the October 2025 Monthly Meeting. The motion passed with a voice vote.

IV: Committee Reports

- Membership-

Chair Floyd reported that we currently have 207 members and thanked members of her committee for their help setting up the meeting.

- Community Events Committee-

Chair Seamster reported on the November 17 Forum that AADC is cohosting with Indivisible Auburn. It will be held at the Placer County Health and Human Services Building in Auburn. The forum will be a viewing of a movie on the Japanese Internment and presentation of several candidates running for office. She asked for volunteers for the event.

- Voter Registration-

Co-Chair Bartlow reported that from August through November 4, the Registration teams registered 45 new voters, with more Democrats registering than other parties.

She also reported that on election day, the Wednesday Team joined the Tuesday Team to help voters.

- Fundraising-

In the absence of a chair, President Campbell reported that AADC will be partnering with the Unitarian Universalist Church to staff a Vote Center at the next election. The club will receive a substantial amount of money for participating and will be using it to hire an accounting firm.

- Communications-

Chair Roughgarden expressed her appreciation for all those writing letters, editorials, and engaging on social media. She also announced that we are still in need of writers and reported on several organizing and training opportunities with Activate America and the Sierra Protection Action Network (SPAN).

V. Updates on Bylaws

President Campbell announced that the proposed version of AADC Bylaws will be sent via email to all members and a vote to adopt the Bylaws will be taken at the December meeting.

VI. Strategic Planning Session (Part II)

Dorian Seamster, assisted by President Campbell and Vice President Parker, explained the process for the second part of the Strategic Planning Session that was begun at the October 2025 meeting.

Those in attendance were divided into three groups, Communications, Community Engagement, and Membership Development and engaged in a discussion on strategies and tactics that could be used by the club in the coming year to further those objectives.
