IV. Officer Updates

- President- Cindy Engen President Engen reported that the No Kings demonstration last Saturday was ruined by an incident with a pellet gun shooting at the crowd. The concern is that copycats will repeat it in the future. A meeting has been organized for this Friday, April 3, 2026 at 10:30 am at the AADC offices with representatives from the Sheriff's office and Supervisor Cindy Gustavson.

V. Committee Reports

- **Membership Committee** - Chairs Floyd and McKenzie reported that the membership of AADC remains the same at a total of 227 members.

Dorian Seamster reported on Public Schools Strong. They need volunteers to

attend the School Board meetings. Local groups may take responsibility for individual schools. Dorian attended the Placer High School recent meeting, which was attended by 20 people. The Board is more conservative than we would like. The Board is elected by District. We need competent people on the School Board. Vacancies are expected soon.

- The Chairs reported that every other Tuesday and every Wednesday they are at Sierra College. They do surveys to engage the students in political discussions. The current survey on the war in Iran reflected that the majority of the students were Very Concerned.

IX. Speakers

President Engen introduced Giselle Garcia, Programs Director of NorCal Resist.

She spoke about NorCal Resist as a political organizing, mutual aid organization with programs led by volunteers. They have only four staff, but hundreds of volunteers.

They run brake light clinics, to prevent pretextual traffic stops. Food donation bins are distributed to 400 people weekly. They have an accompaniment program. They train volunteers to accompany people to court hearings and provide a sense of support, building connections between long time residents and new arrivals. They have Migra Watch (ICE) online training for 25 counties, with 24/7 phone number to report if ICE is present. Someone will be sent to confirm. If ICE is present, they will stay, document, get the detainee's name and A number. The hotline phone is (916) 382-0256. They accept donations at NorCalResist.org. No ICE has been reported at the Sacramento airport. ICE is not conducting sweeping raids in California, but targeted individuals only.

X Member Announcements

Neva Parker announced that she is running for California Assembly, District 5, and has been endorsed by both California State Democrats and AADC. She is having canvassing and post carding (she will provide postcards and add addresses and postage later.

President Engen announced that Judge Leon Dixson, Democrat, will speak at the AADC May meeting. Judge Dixson is endorsed by every judge in Placer County, plus 55 other judges in California. He is running for reelection to the bench against David Bass, Republican.
